- Bidder will not include federal taxes nor State of Alabama sales, excise, and use taxes in bid prices as the City is exempt from (e) payment of such taxes. An exemption certificate will be signed where applicable upon request.
- Bidders shall thoroughly examine the drawings, specifications, schedule, instructions and all other contract documents. (f)

It is the intent of these specifications to describe to describe pediatric medical equipment bags. The equipment will be distributed across the seven color coded pouches according to what is needed to care for patients of a particular size, ranging from newborn to adolescent. For example, if the vendor chooses to use red for newborn patients, the red pouch should have the endotracheal tubes, IV needles, etc. that are the appropriate sizes for a newborn. These specifications are describing and stating the minimum requirements needed to perform necessary functions and tasks for the City's Tuscaloosa Fire & Rescue.

As a result of this bid award, the City intends to make a one-time purchase of a total of seventeen (17) kits of medical equipment specifically designed for providing emergency medical care to pediatric patients. The City reserves the right to increase or decrease the actual number ordered and receive the unit price provided by the bidder in their bid response. If the contract quantities are changed or if the contract expires or is cancelled, no allowance to the Contractor will be made for any change in anticipated profits.
